Sometimes we are moving so fast to keep up with what is going on, we forget to look back to see where we have been. This impact report is an opportunity to reflect on our accomplishments and gear up for another productive year ahead.

We had several distinguished visitors on campus, including Senator Peter Welch, State Treasurer Mike Pieciak, and the Secretaries of the Agency of Commerce and Community Development and the Agency of Natural Resources. We were honored to share our vision of building an inclusive neighborhood here that can help address the housing crisis we face in the region. We also had the opportunity to talk with over 50 neighbors about our planning and conceptual design during three meetings that we held over the course of the year. The feedback we received will be essential as we move into the next phase of development. We also had a resident bear join us in June, but they seem to have moved on.

We received great support from the broader community during our annual Par for the Cause fundraiser, which brough over 120 families to campus for a day of fun. We were also honored to receive a significant donation from the Strolling of the Heifers toward our neighborhood development project. This vote of confidence and financial support from an esteemed community partner is the type of encouragement that helps sustain our efforts.

Understanding that connection is so important to healthy families; last year we bolstered our weekly playgroup for young children and have seen it grow to be a much appreciated and well-attended regular gathering. The group we host for parents with new babies that was paused during the pandemic is now thriving as well. And this fall we are expanding our services even more by hosting a monthly gathering for expectant parents. All three of these free community groups provide peer and professional support to assist families at each stage of the parenting journey.

We look forward to another busy year ahead and appreciate your support as we continue to make a positive impact on our community.

## PROGRAM HIGHLIGHTS

#### **EARLY LEARNING CENTER**

58 children received high-quality early care and education.



### **EARLY INTERVENTION**

We partnered with 128 families in supporting their children who have a developmental delay.

### **SUPERVISED VISITATION**

Our supervised visitation program facilitated 215 family visits.

### **RESPONSIVE NURSING**

Our nursing team responded to 257 referrals for prenatal and postpartum support.

#### CHILD CARE FINANCIAL ASSISTANCE & REFERRAL

367 families applied for assistance in paying for child care for 608 children and 110 families from 24 towns received help finding care.

#### **FAMILY SUPPORTIVE HOUSING**

We supported 21 households with 52 children in their search for stable housing.

#### CHILD AND ADULT FOOD CARE PROGRAM

87,224 nutritious meals and snacks were served to 310 children at 24 child care progarms.

#### EARLY LEARNING EXPRESS BOOKMOBILE

7,454 books were borrowed and 750 storytime visits were shared across Windham County.

45 non-profit organizations and small businesses are now based on the Winston Prouty Campus.

#### **ENERGY EFFICIENCY**

With financial support from the State of Vermont and Efficiency Vermont, we invested in energy-saving projects such a hybrid hot water heater for Holton Hall, smart thermostats, 1300 LED lightbulbs, and e-gauges to measure energy use by building.
